

Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Sunil Bouri S/O LT. Atul Ch. Bouri, Vill-Narayangarh, PO –PK Raj Dist-PURULIA PS- Kashipur has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003, (Amendment) Act-2007.

On dated 01.12.2017 | received a secret complain over telephone that Sri Sunil Bouri S/O LT. Atul Ch. Bouri, Vill-Narayangarh, PO –PK Raj Dist-PURULIA PS- Kashipur Con ID-200855773 consuming electricity by means of tapping from service cable before entering the meter.

On the basis of said complaint at about 10.50 AM I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

Entered the premises of Sri Sunil Bouri and found that he is consuming electricity dishonestly by means of tapping from service cable incoming side to resist actual metering.

Total Load found approx 0.28KW (bulb 2No,CFL-, Fan1 no)
Then we disconnect his service line and seized the following articles.

- 1) Tapping point of service cable
- 2)) Bulb with holder---1no

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 11.20 AM. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
