Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Amalendu Mukherjee S/O LT. Tarapada Mukherjee Vill-Manjhupra PO- Siyada Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 18.12.2017 I received a secret complain over telephone that Sri Amalendu Mukherjee S/O LT. Tarapada Mukherjee Vill-Manjhupra PO- Siyada Dist-PURULIA consuming electricity by means of Tapping from incoming side of meter of WBSEDCL .

On the basis of said complaint at about 2.15 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC

3) Sri Debraj Ray, OE Kashipur CCC.

Entered the premises of Sri Amalendu Mukherjee S/O LT. Tarapada Mukherjee Vill-Manjhupra PO- Siyada Dist-PURULIA and found that sri Mukherjee consuming electricity dishonestly by means of by-passing the meter through a wire from incoming side to stop actual registering of unit. Then we disconnect his service line ,seized the meter bearing no-153692, make-indotech alongwith MCB and one cut out fitted with meter board with proper seizure list . Load found-fan-2 , cfl-2 nos, Total-0.15 KW.

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.45 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
