I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Biswajit Mahato S/O- Late Madan Mahato of Village- Panipathar, P.O- Panipathar, P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)() of the Electricity (Amendment) Act-2007.

On dated 18-12-17 at about 1:30 PM I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,
