

In the matter of an application on behalf of the above named complainant

Most respectfully begs to state:

- That the complainant Sombari Kumar D/o Jagat Kumar has been married with one Sintu Kumar S/o Durga Charan kumar of vill – Durku, P.O.- Chaka, P.S.- Kotshila, Dist – Purulia in the month of Ashar 2011 as per Hindu Rits and Custom of the parties.
- That at the time of marriage as per demand of the Complainant husband as well as his family
 members namely Durga Charan kumar, Pintu kumar, Rishikesh Kumar the father of the
 complainant had to pay of Rs 1,00,000/- (One Lakh) Only as dowry, furniture and many utensil
 and articles.
- That after the marriage the complainant was taken to the matrimonial house of the complainant where she started to live as husband and wife.
- 4. That after her marriage the complainant gave birth of a female chilled and after few days the chilled was expired due to negligence of the husband of the complainant and his family members.
- That there after the complainant could not be mother she was tortured both physically and mentally by all the above named persons.
- 6. That as the above named persons had no intention to keep her in their house and all on a the sudden they asked her to bring Rs-50,000/- from her father and further threatened that if such amount is not paid they will finish her life.
- 7. That as the father of the complainant could not pay the amount of Rs- 50,000/- the accused persons assaulted her mercilessly for which she informed her father and ultimately the complainant was taken by her father to his house on 20th September 2017.





- 8. That the complainant and her father has come to know that on 1st October 2017 the husband of the complainant Santu kumar has married the daughter of Lakhiram Kumar of Vill-Matkuma, and she is residing with her Husband,
- That there after the complainant lodged an information on 3/10/2017 against the above named accused persons at Kotshila P.S. and the O.C. of Kotshila P.S. started Kotshila P.S. case No-122 of 2017 dated 036/10/2017 U/S -498A/494/34 I.P.C. against the accused persons.
- 10. That the accused persons were called at P.S. by the O.C. of Kotshila about the information and or starting of the case.
- 11. That the above named accused persons being furious on 15/10/2017 (28th Ashin 1424 B.S)

 Sunday at about 10.00 Am came to the house of the father of the complainant and started to abusing the complainant and her father and other family member in various filthy language.
- 12. That as the complainant protested against her husband and other accoused about the abusing in filthy/ un-parlamentrlay language to her and her father and immediately the accused Sintu Kumar Press throat of the complainant Saying as "

" and further threatened that neither her father nor any one will be able to do anything against them.

- 13. That due to such hue and cry the father of the complainant came out from their house and saved the complainant.
- 14. That the above named accused persons all were saying to the complainant that as her husband has already married 2nd time and why she is not committing Suicide by roping or consuming poison.
- 15. That as the Complainant lodged information for torture upon her against the accused persons they become ferous and tried to kill her by throttling after creating unlawful assembly and entering the house of the father of the complainant and on the said date she informed at





Kotshila P.S. but as the police officer did not start any specific case accordingly the complainant lodged an information to S.P. Purulia on 23/10/2017 but neither the O.C. Kotshila P.S. nor S.P. Purulia has taken any steps to start specific case for which the complainant has been compelled to file this petition U/S 156(3) Cr.P.C. before this Ld. Court.

16. That the above named accused persons after creating an unlawful assembly forcibly entered into the house of the complainant and tried to kill the complainant by throatily for which the accused person be adequate punished as per law.

It is therefore prayed that your Honour's may be graciously pleased to pass an order to send this petition to O.C. Kotshila P.S. with a direction to investigates the facts of this case treating this petition as F.I.R. and to send report to this Ld. Court.
