On 28.12.2017 at about 12.30 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Haragobinda Singh Mura, OE, entered the premises of Sri Haribol Kumar, S/O- Jagannath Kumar of village:-Hinjari Shayampur, P.O- Hinjari Shayampur P.S- Kotshila, Dist- Purulia and found Sri Haribol Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.26 KW. As Sri Haribol Kumar, S/O- Jagannath Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato, Gr1 TSH 2. Haragobinda Singh Mura, OE. The inspection team left the premises at 12.45 PM.
