Jabbar Ansari of village:- Chamchaka, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 28.12.2017 at about 1.15 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Haragobinda Singh Mura, OE, entered the premises of Nasir Ansari, S/O- Lt. Jabbar Ansari of village:- Chamchaka, P.S- Kotshila,, Dist- Purulia and found Nasir Ansari, was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 1.1 KW. As Nasir Ansari, S/O- Lt. Jabbar Ansari committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato, Gr1 TSH 2.
