I do hereby lodge a complaint empowered by enabling the Electricity Act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Dhananjay Soren, S/O- Gaganam Soren of Village- Bukkhela, P.O- Jitijuri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 07-12-17 at about 01:30 PM I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Dhananjay Soren, S/O- Gaganam Soren of Village- Bukkhela, P.O- Jitijuri, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisely by direct hacking from respective CT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)() was detected. It was also found that he/she was using the following electrical equipments -
