Dear Sir,

Inspection conducted by the security guard and ASSI of Dubeswari Colliery along with the ASSI of Parbelia Colliery that rampant illegal coal mining has been carried out under the lease hold area of Dubeswari Colliery under Sarbari Mouza. ***The illegal mining activities are also visible from colliery premises.*** It is noted that illegal digging/blasting for the purpose of coal mining, the situation of Dubeswari Colliery will be endangered at any time by in rush of water from the illegal pits into the mine of Dubeswari Colliery and also by occurrence of fire by entry of air through the illegal pits after making touch of air with the coal pillars in the underground for which safety provision will be violated and it will creates serious danger situation and threat to life for the miners/employees of Dubeswari Colliery working in U/G and will cause loss of national property as well.

It is to be noted that recently the illegal mines were filled up and the filled up illegal pits has been reopened by the miscreants.

Location: - 1) North side of Dubeswari Colliery (Clearly visible from Dubeswari Colliery Sand bunker)

2) South- West Side of Dubeswari Colliery.

You are therefore requested to intervene into the matter immediately and take steps and measures to stop the illegal coal mining in the above mentioned location to maintain safe condition of the mine working Dubeswari Colliery, so that the miners/employees working in U/G can work and discharge their duties safely and the loss of national property with process of illegal mining can be prevented from the miscreants, involved in their illegal act
