Seizure list was prepared at the site and accused person refused to sign/signer.


The inspection team left the premises on 01-12-2017 at 16:40 hrs.

The accused person has committed an offence U/S 135 (I) (a) of The Electricity Act-2003 & subsequently Electricity (Amendment) Act-2007.


You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
