Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **KUDDUS ANSARI, S/O- HANIF ANSARI** of Village- BAHARA, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 19.12.2017 at about 1:05PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E), Dubra Para CCC, Mr Bilash Mahto Gr I TSH of Dubra Para CCC, inspected the premises of **KUDDUS ANSARI, S/O- HANIF ANSARI** of Village- Bahara, P.S.-Para, Dist Purulia WBSEDCL. During inspection and it was found that the said **KUDDUS ANSARI** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 no CFL, 01 no ceiling fan, approx load 0.075 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 1:20 PM.

As such **KUDDUS ANSARI S/O-HANIF ANSARI** of Village-Bahara, P.S.- Para, Dist-Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
