



D.Place, Date and time of occurrence:-

Occurrence took place of village Dakshin Bahal, P.S.Purulia (M), Dist.Purulia (W.B.) on and from 22-05-2011 still continue.

E.Offences: -

The above-named complainant begs to state as follows:-

Most respectfully sheweth: -

1.---That the complainant is the legally married wife of accused No.1 Arif Ansary. Their marriage was solemnized on 12-05-2011 as per Islam rites and customs at village Tentalda, P.S.Para, District Puruliaand their marriage is still subsisting.

2.---That Den-Mohar was fixed Rs.20,051/-(Rupees Twenty thousand and fifty one) only at the time of marriage the father of the complainant gave a cash of Rs.70,000/- (Rupees Seventy thousand) Golden and Silver ornaments, furniture, utensils etc. to the accused person No.1 to 7 as per their demand as dowry.

3.---That after marriage the complainant had been to matrimonial house and lived with the accused No.1 as husband and wife along with the other inmates of the family and started her matrimonial home with lots of dreams and aspiration and the marriage was duly consumated.



4.---That mental life of the complainant was not happy after few days of the marriage i.e. and on and from 22-05-2011 she was subjected to torture, harassment and illtreatment not only at the hands of accused No.1 but also at the hands of the accused No.2 to 7.

5.--That the accused persons No.1 to 7 pick up quarrel with the complainant on filmsey grounds and they used to assault the complainant by fists xdm and blows and by slaps. In sufficient food and clothing was not given to her and she has not allow to sleep in side the room.

and delivered a male child namely Firdonsh Ansary on 13-04-2014 at Paralibut the accused persons never bothered to came to at Paralito see the baby and nothing to pay the cost of treatment etc. including fooding of the mother and the baby. That after giving birth to a child was again went to my matrimonial home and again started to live there with accused No.1. But conjugal life was not really happy due to the unnatural behaviour and adament attitude of the part of the accused persons and as a matter of fact torture as stated here in above was continued.

7.--That the accused persons No.1 to 7 on many occassion told the complainant that in sufficient dowry was given in the marriage of the accused No.1 for which they asked the complainant to bring more and more money from her father. The complainant and her father expressed their p.T.⁰.



assaulted the complainant by fist and blows and complainant pulled her har well and tried to pushed her in the well, but the complainant shouting loudly BACHAO, BACHAU hearing the sound many villagers assembled there and the complainant any how saved her life. Lastly at 9 p.m. accused persons No.1 to 7 after assault and snatching all the ornaments and drove the complainant and her son from her matrimonial home. There after complainant was taken shelter in the School room and want next she came to Purulia and there after her father's house and since then the complainant has been staying in her father's house.

9. That the accused persons No.1 to 7 still threatening to kill the complainant and her father, mother and brother by different ways, that due to constante threatening, torture, illtreatment, harassment by the accused persons to the father, mother, brother and complainant, the complainant became sicking nervous and failed on insequire

and for which the complainant informed the above incident to the local police of Purulia (M) P.S. There after to S.P.Purulia but the Police of Purulia (M) P.S. are quite mum and has not any police case against the present accused persons. So the complaintwis bound to file this instant petition for proper relief.
