I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Sristidhar Rajwar S/O Lt. Khandu Rajwar of Vill - Hutmura, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 19.12.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Sri Debdulal Banerjee, Sr. TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Hutmura under Purulia(M) P.S. When our team at about 11.00 P.M. entered to the Commercial premises of Sristidhar Rajwar, we found that he was enjoying electricity dishonestly by means of Direct Hooking From Nearest LTOH Line and run electric bulb at his poultry farm, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.30 P.M. after completions of inspection & necessary formalities.

Sristidhar Rajwar S/O Lt. Khandu Rajwar of Vill - Hutmura, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
