Entered the premises of ~~the~~ new constructed house of Heera Banerjee at Amdaha where he is presently residing

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I)(a) was detected.
