Sub.-: Complaint against Mr. Samir Das, Laboratory Assistant & Sidho Knho Birsha University & resident of Bhagabandhpra, Purulia.

Sir,

I Smt. Jyotsna Mahato, wife of Shib Shnkar Mahato, resident of Ear Ali Dhopa Lane, Nilkuthidanga, Purulia would like to draw your kind attention in the matter of complain against one Sri Samir Das Laboratory Assisstant & Sidho Knho Birsha University and resident of Bhagabandhpara, Purulia.

Mr. Samir Das with two other persons came to my house blowing his horn of motorcycle as loudly as possible yesterday i.e. on 3rd Dec. 2017 at @ 11:35 P.M.. They called my elder son sri Pijush Kanti Mahato who resides in my house. My elder son went with them and I felt something wrong had happened as I apprehend some scuffle might have been taken place between them. After a few minutes Mr. Samir Das with two unknown persons had taken away my elder son. Almost half an hour later Mr. Samir Das came to my home this time with his elder sister shouting derogatory abusing words towards all female members of my house. At the age of 61 it is quite astonishing as well as derogatory to me. Mr. Samir Das fisting into the walls injuring himself while shouting those abusing words. My elder son Pijush Knti Mahato was not present at home at this point of time. The localities of my house came helpful as they forcefully taken Mr. Samir Das away. After 10 minutes my elder son Pijush Kanti Mahato came back home with lot of injuries in his face and other parts of bodies.

Now I am in terrible shock of this fearful act of Samir Das as he repeatedly threatens us to come again and again with miscreants to abuse us. My younger son is an employee of State Govt. of West Bengal under Directorate of Micro Small & Medium Enterprises, he also resides in my home and he is under great trauma. In his mental state his duties towards common people of Purulia may be hampered. My husband is now 70th (seventy) years old and had been suffering from Cerebral Attack since 31st January 2017 (Copy enclosed herewith), if anything happens to his ailing health Mr. Samir Das will solely responsible for that.

Moreover my younger son had his first baby child with his wife Mrs. Usha Mahato, on 29th November 2017 (copy of Birth Certificate is enclosed herewith). So a 5 (five) day old baby and his mother in her weak condition of health is also suffering to great extent in this utterly inhuman incident.

I want a stern and immediate action against Mr. Samir Das to stop him from repeat such derogatory action in future. For my safe guard I may Install Close Circuit camera in my house to produce evidence for such miscreants.

This is for your kind information and taking necessary action.
