Sir,

In Producing herewith one person namely Arabinda Hazari S/O Dhiren Hazari Of Vill+PO- Pirargoria, PS- Purulia (M), Dist- Purulia before you with a history of Police assult to the effect that today i.e. 26.12.2017 at about 12:15 hrs while I along with JC/220 Sibuduley, JC/222 Abhijit Duley, NVF/403 Krishnapada Kumar were performing vehicle checking duty at Victoria More under Purulia (T) PS vide Purulia Sadar Traffic GDE No. 241/17 dated 26.12.17. The said person arrived there and started to shout loudly with an introduction of local leader and demanded not to check vehicle regularly to avoid public harassment. On protest by our on duty JC/222 Abhijit Duley in full uniform said person hold the collar of the uniform and assaulted him. When I tried to stop it he also assaulted me on my face and other parts of body. This results a panic in the locality. Somehow we managed to bring him at Purulia (T) PS.

Hence I request before you to lodge an FIR against him under proper section of Law and arrange for an investigation.
