Sir,

This is to inform you that miscreants broke into the branch premises through the southern side stair wall. The issue came to our notice at 9:30 am dated 04/12/2017.

When our Branch Armed Guard Mr. Dipak kr Goswami and Staff Clerk Mr. Rishikesh Kumar opened the branch for the day's business. The burglar/s broke the wall, tampered the CC TV camera at vault, broke all the locks at Vault gate and entered the vault room. They also disconnected the sensor connections and tried to break the main cash vault. They could only break the knob but the main vault is otherwise intact.

After inspection in presence of Police officials it was found that the miscreants could not steal any cash.

Hence sir we request you to lodge an FIR in this connection and investigate the issue.
