Officer-in-Charge 1.3. That on 10/04/2017 at about 3.30 P.M. while the complainant with his sons namely RAGHUNATHPUR 1.3. Dist-Purulia (W.ESK.Ajad, SK. Nausad and SK.Samsad working in their own land at Village – Bamarrah,

- P.S. Raghunathpur, District Purulia, suddenly the above named accused persons armed with pick-axe, spade, iron rod, stick etc. forcefully entered into the land of the complainant and started to digging his land with the help of pick axe, and spade and when the complainant raised objection the above named accused persons assaulted him over his head with a iron road and tried to killed him. However your complainant sustained severe bleeding injury on his left hand while he tried to defend him from the blow of iron rod. Your complainant also sustained serious injury in right eyes also. When the sons of the complainant namely SK.Ajad, SK.Nausad and SK.Samad tried to rescue the complainant from the clutch of the Accused persons they have also been beaten up by the accused person by the spade, pick-axe, and iron rod over all their body and due to such assault Sk.Ajad sustained serious bleeding injury on his head and fell down on ground SK.Nausad and SK.Samsad also received serious injury all over their body.
- 2...That upon hearing hue and cry SK.Guljar (Witness No.5), SK. Harun (Witness No.6), SK. Kurban (Witness no.7), and MD.Juber (Witness No.8), reached the spot and tried to save the complainant from the clutch of the Accused Person and the accused person become more furious upon seeing them and also started to assault them with deadly weapons like pickaxe, spade, iron rod, etc. and as a result of such sever assault SK.Harun and SK. Gulzar sustained very serious injury over his head and fell down on ground and all the injured persons were lying there till the co-villager came there for rescue the complainant and other injured persons.
- 3...That the complainant and the injured person were taken in to Raghunanthpur Sub Division Hospital by the co- villager from there they have been referred to Bankura Sammilani Medical College and Hospital for better management as the nature of injury sustain by the victims were grievous in nature. The Xerox copy of injury report has been annexed with this Misc. Petition.
- 4...That the injured persons were admitted and treated at Bankura Sammilani Medical College and Hospital for long period of times. When the Complainant after released from hospital went to Raghunathpur P.S. for lodging a F.I.R. against the accused persons but the reason best known to the O.C. Raghunathpur P.S. till the 21.11.17 no action has been taken against the accused person and upon asking the police officer told the complainant that no case has been registered on the basis of the complaint lodged by the complainant against the above named accused person.
- 5...That till date the accused person roaming freely and also started to threaten the complainant and their family member with dire consequences. The complainant and his family members are spending each and every day out of fear and mental agony upon the threat received from the accused persons.
