You are certainly aware that the Railway linkage work of RTPS is to be completed at the earliest for transportation of coal through rail. As reported by M/s RITES, the agency who have been entrusted the job, yesterday while carrying out the work of formation at Digtila Mouza, some people have forcibly stopped the work without any valid reasons.

In this connection, it is to mention that suspension of work even for a single day may jeopardise the program for completion of the railway linkage.

It is requested to take needful action to enable us to resume the work immediately.
