Ltd." of Indus Towers Limited, Godrej Waterside, Saltlake Electronics Complex, Kolkata - 700091. We are provide technical support to the Indus mobile towers by local man powers.

We have a Indus mobile towers namely "Kadamara" bearing Indus Id no. IN-1265429, situated at near Jainam Danga Rail gate, Konb Forest, Vill - Kadamara, PO - Choropahari, Dist - Purulia under your Police Station area. Today, on 17th Dec, 2017 at about 10 am. it has been detected by our landowner Benuhi Bauri that some unknown criminals committed theft in respect of 18 nos. Battery Cells of Amara Raja 600AH Battery Bank set from the said towers site.

It may be mentioned here that BSS Engineers Ajay Mondal (M-9609402779) of Vodafone stop the alarm system of the towers and didn't informed the technician Prasanta Karmakar (M-7797200670) or anybody of NIPL. As such the alarm of the towers didn't functioned during the time of theft on yesterday night.

As such I requested goodself to start a case and take action as per law.
