I, Sri Tapas Kr. Ghosh, Inspr. of Police, DEB, Purulia, do here by lodge complaint being produced the accused Mujahid Ansary s/o Alauddin Ansary of Gopinathpur Natun Basti, PS Raghunathpur, Dist Purulia alongwith the seized articles (1) 105 (One hundred five) ltrs. Of Blue Kerosene Oil in 03 (three) plastic jerricans as well as Memo of Arrest including relevant documents to the effect that today 20.12.17 in persuasion of secret information myself alongwith C/72 Sribas Mahato, HG/1625 Mohan Hansda & HG/1590 Bishnu Pada Mahato had been to Raghunathpur PS and noted the information at Raghunathpur PS at 09:15hrs, vide Raghunathpur PS GDE No.1206 dtd.20.12.17 and also submit a requisition to OC Raghunathpur PS for rendering assistance. Thereafter, myself alongwith force left for Gopinathpur Natun Basti village under Raghunathpur PS to work out the information by availing hired Govt, vehicle bearing Regn. No. WB 56J/3748 on arriving at Gopinathpur Natun Basti village, took effective entry into one grocery shop there in the name of Mujahid Ansary after placing guard within the entire periphery and it could be learnt that the owner of the shop is the said Mujahid Ansary.

Thereafter, we restrained one person who disclosed his identity Mujahid Ansary s/o Alauddin Ansary of Gopinathpur, PS Raghunathpur, Dist Purulia. On searching the said premises a huge quantity of Blue Kerosene Oil were found stored inside the shop and on asking followed by issuing a notice to produce any documents / license in respect of storage of such Blue Kerosene Oil in accordance to the Essential Commodities Act. He failed to produce any constitutional documents in his favour for possessing the same. As such I seized the articles as mentioned in the seizure list in presence of witnesses from the possession of said Mujahid Ansary after proper weighment and making proper labeling of seized article.

He was willfully violating the provision of Para 4 of West Bengal kerosene control order 1968 and committing an offence punishable u/s 7(i)(a)(ii) of Act X 1955, it is also to be noted that the Mujahid Ansary is habituated in dealing with clandestine storage and sold Blue Kerosene Oil in Black Market in high rate and thereby deprived poor consumers as well as causing loss of revenue to Government. Accordingly said Mujahid Ansary s/o Alauddin Ansary of Gopinathpur Natun Basti, PS Raghunathpur, Dist Purulia was arrested after informing him ground of arrest and issue Memo of Arrest to him in presence of his father duly signed by him. I therefore request you to start a case u/s 7(i) (a) (ii) of Act X/1955 against Mujahid Ansary s/o Alauddin Ansary of Gopinathpur Natun Basti, PS Raghunathpur, Dist Purulia.
