Entered the premises of KINKAR BAURI, S.O- Late. ASHUTOSH BAURI of Village- Rangamati, P.O- Babugram, P.S- Raghunathpur, Dist-Purulia. and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from terminals of meter no. 341900 i.e. KINKAR BAURI, CON ID- 242321128

Supply i.e. U/S 135 was detected.
