Entered the premises of KINKAR BAURI, S.O- Late. ASHUTOSH BAURI of Village Rangamati, P.O- Babugram, P.S.- Raghunathpur, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from terminals of meter no. 341900 i.r.o. KINKAR BAURI, CON ID - 242321128

Supply i.e. U/S 135 was detected.
