Entered the premises of Mr. Pradip Kr. Sarkar, Vill. Bagra P.S. Santaldihi, Dist- Purulia, having Consumer No. 2011 00310. Meter No. B2200473 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- (1) Pump - 01, (2) TV - 01, (3) Fan - 04 (4) Tube light - 04
- (5) Exset - 01.


Out of which I seized the following. *in presence of local Repole*
