and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing  
the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage  
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his  
house without energy registration in WBSSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Pump - 01,
- 2) TV - 01,
- 3) Fom - 04
- 4) Tube light - 04
- 5) Exset - 01.

Out of which I seized the following in presence of local Repole  
1) Pvc service connection cable 2 core along with By Pass  
arrangement - 04 ft (able)

the premises at 2.10pm on 12/12/17. The accused person has committed an offence
