1 ASI Giridhari Roy of Adra P.S. do here by lodged a complaint against accused namely Sivnath Mukhi (24 Yrs.) S/O Bijoy Mukhi of Seve Nagar, Pry. School, Adr PS- Adra Dist- Purulia to the effect that on 28.01.18 at about 18:15 hrs. in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one namely Sivnath Mukhi (24 Yrs.) S/O Bijoy Mukhi of Seva Nagar, Pry. School, Adr PS- Adra Dist-Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/572 Ajoy Giri & JC/ 342 Kashinath Chakraborty rushed to the spot for raid by Govt. vehicle. At about 18:45 hrs. myself along with force reached at Seva Nagar and hold raid in the Jhupri of Sivnath Mukhi (Near Sevanagar Pry. School) and found that said Sivnath Mukhi sealing liquor at his own Jhupri and seeing the Police party some person fled away and said Sivnath Mukhi to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Sivnath Mukhi (24 Yrs.) S/O Bijoy Mukhi of Seva Nagar, Pry. School, Adr PS- Adra Dist-Purulia and arrange for its investigation.
