Today i.e. 02.01.2018 at 18.45 hrs reached at Duarasini more within a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle in a hiding place; we ambushed ourselves at different places with proper briefing. Kept watch at the pacca road extended between Kukru & Duarsini more. At about 19.05 hrs one motorcycle rider, identified as Panchanan Kumar @ Pencha pillion rider duly identified by source as (2) Sarifuddin Momin @ Chatu(40)S/O Ismile Momin of Vill-Kuki , P.O-Ichag P.S. Jhalda Dist-Puriulia, (3) Afdul Salam @ Chhatnu(31)S/O Lt. Yakub Momin of Vill- Raghunathdih, P.O.- Birgram, P.S.-Baghmundi, Dist-Purulia with one Hero Splender PRO red colour motorcycle bearing registration number WB 56K 2155 with a loaded plastic bag at Duarsini More (Bagmundi-Balarampur road). We watched them for a considerable period, meanwhile, I along with accompanied officers & force disclosing our identities surrounded them & also detained them with the said bag. Being asked, they disclosed their identity as (1) Panchanan Kumar @ Pencha(42), S/O Merkhu Kumar of Vill; Marcha, PS Baghmundi, Dist Purulia (2) Sarifuddin Momin @ Chatu (40) S/O Ismile Momin of Vill-Kuki, P.O-Ichag P.S. Jhalda Dist-Puriulia, (3) Afdul Salam @ Chhatnu (31)S/O Lt. Yakub Momin of Vill- Raghunathdih, P.O.- Birgram, P.S.- Baghmundi, Dist- Purulia On interrogation, they confessed that, said bag contained Cannabis/Ganja. They also stated that they were carrying the same for selling at Baghmundi area. I informed the matter to CI, Balarampur and SDPO Jhalda. Thereafter, I issued notice to the three accused persons asking them whether they are willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, all three detained persons gave their willingness in writing to be searched in presence of an Executive Magistrate, accordingly informed to S.D.O. Jhalda to provide Executive Megistrate for search and seizure as per provision of section 50 of NDPS Act and he deputed Sri Abhishek Biswas, B.D.O. Baghmundi Block (Executive Magistrate). Meanwhile, we searched for public witnesses with the help of accompanied officer & force. After a while two public witnesses namely (1) Sudeb Mahato S/O Surjakanta Mahato of Vill- Kushaldi, PS- Baghmundi, Dist-Purulia and (2) Rezwan Khan S/O Abdul Goni of Vill- Uttamdih, PS- Baghmundi, Dist-Purulia came and they became ready to assist us in conducting search & seizure. Within 30 minutes CI Balarampur and B.D.O. Baghmundi Block, arrived at the spot and disclosed their

dentity and explained the reason for arriving there. After their arrival I started search & seizure process at P.O. Then I offered the said detained persons to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Abhishek Biswas, B.D.O Baghmundi Block and detained persons. At first myself with the help of officers and force searched Panchanan Kumar @ Pencha and Sarifuddin Momin @ Chatu and Abdul Salam @ Chhatnu and their belonging at the spot. During search as per direction of B.D.O. Baghmundi Block, I opened the bag and found Cannabis/Ganja in that bag in presence of witnesses. Thereafter I weight it and found 25 KG Cannabis/Ganja inside the bag. Accordingly I seized the said bag, 25 Kgs Ganja/ Cannabis and taking three (03) samples of 100 grams each in brown coloured envelope from said bag under proper seizure list duly signed by the public witnesses, police witnesses and accused persons in presence of B.D.O. Baghmundi Block with help of weighing balance, weights etc. Also packed, sealed and labeled the same at the P.O. with the help of accompanied officers and force and made over one copy of seizure list to the accused persons. one Hero Splender PRO red coloured motorcycle baring registration number WB 56K 2155 and having engine number S2897CM3GBG & Chassis number MBLHA10BFFHB33025 from the possession of rider namely Panchanan Kumar @ Pencha (42), S/O Merkhu Kumar of Vill; Marcha, PS Baghmundi, Dist Purulia. The Cannabis/Ganja is prohibited narcotic drugs which they were dealing in lieu of money which violating Sec. 20 (b) (i)/29 of NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested them. Informed them ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and labeling were done between 19.35 hrs and 21.45 hrs under direct supervision of BDO Bagmundi Dev Block and CI Balarampur, Purulia.

Yakub Momin of Vill- Raghunathdih, P.O.- Birgram, P.S.- Baghmundi, Dist- Purulia and endorsed SI Koushik Banerjee of Suisa OP under Bagmundi
