Sub: Request to lodge FIR against (1) Md. Murtuj (2) Mr. Bikram and other anti social elements of the adjoining locale for committing criminal confinement, inflicting grievous hurt and injury and looting of Cash from our site office at Ayodhya Pahar, Purulia.

Sir,

1..That the undersigned is an authorized persons of M/s Pearltrees Hotels & Resorts Pvt. Ltd. to lodge this complaint, on it's behalf . We have valid license and necessary permission from the Government of West Bengal to maintain their resort at Ayodhya Hilltop Pahar, after necessary renovation of the existing cottage and bungalows there at .

With all our efforts we have managed to come up with the said Resort in association with the Govt. of West Bengal having all the Facilities and Amenities of International Standard with the only Motive to Develop Tourism Industry in the Most Backward region of West Bengal - Purulia , and for which even a Delegates of **CII -East** has scheduled there visit to our property from 18th Jan 2018 to 20th Jan 2018 .

2..For, the aforesaid renovation purpose, we hired manpower (casual and daily wages labours) from the available sources and having knowledge of our requirement of manpower, one Md. Murtuj , and Mr. Vikram, approached our site in charge Mr. Mirazul Islam to give him an opportunity to supply manpower as and when required on daily wages basis.

3.. Believing him as sincere and honest person our site in charge allowed him to supply manpower to work at above referred site. Initially, to gain our confidence he used to come up with proper workers but subsequently

his workers were changed and it was noticed and found that they were causing damages having no previous experience for the works for which they were engaged. They deceived us by saying that they have a huge experience in similar nature of works, which they otherwise no experience at all. They defrauded by making such wrongful representation. On the other hand, their men engaged in such renovation purpose was found committing theft of valuable goods rampantly from the aforesaid resorts/site.

4..Due to aforesaid reasons , on 5th January, 2018, we had requested said Md. Murtuj not to come to our site and we do not want to continue with him and his worker as they were causing huge damages and loss to us and more importantly his workers were red handed caught in theft of valuable goods at site.

5.. On that first of all he threaten our other site personal with dire consequences and also said that their life is in danger now onwards. Today, at about 08:00 PM said Md. Murtuj and Mr. Bikram along with various anti-social elements forcefully entered our said Kushal Palli resort at Kachurirekha , Ayodhya Pahar Hill Top , resort/site with Iron road and chain and other Weapons and started mercilessly beating our men and security. They confined our Mr. Amardeep working as Store In Charge and 2 other personal namely Mr. Sanku Lahiri and Mr. Rajdeep in a small room and locked them from outside. They also driven out the other men and security by abusing and beating them with the aforesaid weapons and thereafter forcefully entered into our cash office and broke open the cash box and looted away more than Rs.2,50,000/- from Cash. Not only that they have looted other imported and valuable goods kept therein.

6..When the illegal activities was going on, at the instance of said Mr. Amardeep , our other security personnel informed the other adjoining villagers who rushed in the place of occurrence, in huge numbers. Seeing the aforesaid villagers who came to rescue us, said Md. Murtuj along with their all anti social elements fled away from said place.

7..That the villagers thereafter rescued our men from such confinement. But they have failed to recover the cash from those anti social elements.

8..In the premises, I am requesting your goodself to treat this complaint as a FIR against the above named accused persons and their other anti-social elements and ensure proper punishment thereof, for such heinous crime, committed today against us, upon book them for trial before the appropriate court of law.
