Sindri, Dist- Purulia and found Sri Basudeb Mahato was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Basudeb Mahato S/O- Sri Nageswar Mahato committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sojal Kumar Mahanta, O.B 2. Sri Gurpratap Singh, H.C.T.S.H The inspection team left the premises at 2:50 P.M.
