## Sub : Detail Report of an attempt to snatch weapon from sentry post at NAP Hill Top Camp.

Sir,

With reference to the subject cited above. The undersigned would like to state the detail incident report that took place in Ajodhya Hill Top NAP Camp.

That, on 29-01-2018 at 0940 hrs the undernamed attempted to snatch the barrel of the LMG which was mounted in sentry post near the main gate but was however, swiftly caught and apprehended by the sentry. It may be noted that the Alpha Coy NAP Ajodhya Hill top camp falls under the WBCADC Complex. The CADC has many workers/employees who frequently move around to look after the garden which is just adjacent to the front sentry post of the camp, so movement of persons cannot be strictly restricted near the front gate. Upon enquiry towards CADC officials it was found out that he was not an employee of CADC (Enclosed Statement).

An attempt to snatch weapon of armed personnel that also in a LWE affected zone is a serious offence and could have invited counter retaliatory actions/responses but our personnel showed utmost restraint not to do so. Therefore, I request you to kindly investigate and find out the facts and circumstances and also the motive behind it and intimate the undersigned at the earliest. Thank you.
