Respected Sir,

In producing here with 02 (two) arrested accused persons namely 1) Rajib Gorai (23 yrs) S/O- Lakhan Gorai of Vill.- Bhikari Chaliama, P.S.- Barabazar, Dist. Purulia, 2) Dipak Singh (21 yrs) S/o- Chandra Mukhi Singh of Parkidih, P.S.- Balarampur, Dist.-Purulia along with seized 22 (twenty two) sealed country spirit bottles (DIL Se) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 16:45 hrs I received a credible source information that 02 (two) persons namely 1) Rajib Gorai S/O- Lakhan Gorai of Vill.- Bhikari Chaliama, P.S.- Barabazar, Dist. Purulia, 2) Dipak Singh S/o- Chandra Mukhi Singh of Parkidih, P.S.- Balarampur, Dist.-Purulia are selling country spirit without any valid license from Pratima Hotel near Berma Check Post under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Pratima Hotel near Berma Check Post to work out the source information and held raid in the Hotel of accused persons.

During search with the help of accompany force, we found that the above noted persons are selling country spirit bottles at Pratima Hotel. On demand, they failed to produce any valid documents/ License in respect of selling and keeping of said country spirit. Accordingly, I seized all the sealed country spirit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 13.2 (thirteen liters & 200 ML) country spirit has been seized, total value of the said seized spirit is Rs- 770/= (seven hundred seventy only) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused persons namely 1) Rajib Gorai S/O- Lakhan Gorai of Vill.- Bhikari Chaliama, P.S.- Barabazar, Dist. Purulia, 2) Dipak Singh S/o- Chandra Mukhi Singh of Parkidih, P.S.- Balarampur, Dist.-Purulia and arrange for its investigation.
