Sub F.I.R. against Unauthorized use of Electricity against MADAN ORANG 5/O LT. RAMANATH ORANG having of Vill-BANDWAN MUDIDIH, P.S. Barabazar, Dist-Purulia, U/S 135(1)/A of the electricity (Amendment act-2007)

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003 "subsequently electricity act-2007, to the effect that MADAN ORANG S/O LT. RAMANATH ORANG having of VIII- BANDWAN MUDIDIH, P.S- Barabazar, Dist-Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of single core flexible wire and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 04.01.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) JIAUR RAHAMAN MONDAL, A.E.(E), S&LP UNIT, PURULIA REGION, WBSEDCL
- (2) CHANDI CHARAN KARMAKAR, C.M, BARABAZAR CCC, WBSEDCL
- (3) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 01:50 P.M., entered into the premises of MADAN ORANG S/O LT. RAMANATH ORANG having of Vill- BANDWAN MUDIDIH, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill.- BANDWAN MUDIDIH, P.S Barabazar, DIST-Purulia.

During inspection, it was found that MADAN ORANG S/O LT. RAMANATH ORANG having of VIII- BANDWAN MUDIDIH, P.S-Barabazar, Dist.- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of single core flexible wire in his premises at BANDWAN MUDIDIH having connected load 0.3 KVA.

From the above arrangement he was using the following equipment:

- 01. 03 nos Electric fan
- 02. 01 no Electric Tube Light
- 03 04 nos CFL

Out of which I seized the following articles:

- 01. PVC Single core flexible wire (14 mts. App.) along with hooking device.
- 02. PVC 2X1 core wire along with 05 pin plug base supported on PVC small board (09 mts. Approx)

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 02.10 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act-2007.
