I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect that , SHYAMSUNDAR MAHATO S/O KISHTU MAHATO having consumer ID- 242314562 and meter number- 0654354 of Vill- BANKATI, P.S- Barabazar , Dist- Purulia was enjoying electricity unauthorizedly by meter bypassing with the help of 2X1 core flexible wire and he has committed theft of electricity U/S 135(1)/B of the electricity (Amendment act-2007).

On 04.01.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) JIAUR RAHAMAN MONDAL, A.E.(E), S&LP UNIT, PURULIA REGION, WBSEDCL
- (2) CHANDI CHARAN KARMAKAR, C.M, BARABAZAR CCC, WBSEDCL
- (3) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 02:35 P.M., entered into the premises of SHYAMSUNDAR MAHATO S/O KISHTU MAHATO of Vill- BANKATI, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- BANKATI, P.S Barabazar, DIST- Purulia.

During inspection, it was found that SHYAMSUNDAR MAHATO S/O KISHTU MAHATO of VIII- BANKATI, P.S- Barabazar , Dist- Purulia was enjoying electricity illegally by meter bypassing with the help of 2X1 core flexible wire in his premises at BANKATI having connected load 0.28 KVA. He is a consumer of WBSEDCL having consumer ID- 242314562 and meter number- 0654354.

From the above arrangement he was using the following equipment:

01. 01 NO ELECTRIC FAN
02. 01 NO Color TV.
03. 01 No. Bulb (100 Watt)

Out of which I seized the following articles:

1. Energy meter vide meter no. 0654354 along with bypassing arrangement.
2. 01 No. Bulb (100 Watt)
