Sir,

I, SI Swapan Majumdar of Hura PS, Dist- Purulia do here by lodge complaint against some unknown persons to the effect that today on 24.1.18 at about 20.30 hrs while I along with C/ 295 Badrul Hazari C/64 Suresh Dutta , NVF 099 Bimal Gorai and other force were performing L/O duty in c/w Saraswati Puja at Jambad village Namopara under Hura PS that time received an information from reliable person that some unknown persons restrained three persons namely Sk. Jakiruddin @ Sk. Kota @ Sk. Kotu of Hutmura PS-Purulia (M), Sk Babua and Sk. Nasim both of Jambad village PS-Hura and assaulted them. After receiving said information we rushed to the spot at Jambad village near Shib Mandir and found that some unknown persons were assaulted them by fists and blows. The Police party rescued them from mob and found one of them namely Sk. Jakiruddin @ Sk. Kota @ Sk. Kotu of Hutmura PS-Purulia (M) was assaulted brutally by the said unknown mob on his person and on seeing Police party the mob fled away. The injured person shifted to Lodhurka PHC for treatment.

Therefore, a case against some unknown persons may kindly be started under proper section of law and arrange for its investigation.
