
Sir,

In producing herewith the aced Giasuddin Ansary (41) s/o Mohiuddin Ansary of Vill- Hijuli, PS- Hura, Dist- Purulia along with seized truck bearing No- JH09Q/3423 with loaded stone under proper seizure list. The fact of the case in brief is that on 21.01.18, I SI bablu Ghosh along with C/522 Rupalal Tudu and JC/859 Ujjal Banerjee all of Hura P.S were performing mobile duty on Purulia-Bankura Pitch Road (NH 60A) main road with Govt. Vehicle bearing No- WB 56C/0016. During mobile duty at about 14.05 hrs I received credible source information that the above noted truck was coming from Bankura side towards Purulia loaded with stone illegally. After receiving that information we were proceeding towards Pather Sathi Motel (Check Post) under Hura P.S. When we reached near Pather Sathi (Motel) under Hura P.S, found that the above noted truck was coming from Bankura side on 21.01.18 at about 15.05 hrs. We gave signal to stop the vehicle but the driver speeded away. After hot chasing we managed to stop the vehicle at Pakhuria More and driver of the said vehicle tried to flee away but we also manage to apprehend him and searched the said truck and found that the truck is loaded with stone. I asked the driver to produce any valid documents in respect of stone loaded in the truck as well as the valid documents in respect of that truck but he failed to produce any valid document in respect of stone and truck. Hence I arrested driver Giasuddin Ansary (41) s/o Mohiuddin Ansary of Vill- Hijuli, PS- Hura, Dist- Purulia after observing all formalities and seized the truck bearing JH09Q/3423 loaded with stone under proper seizure list in presence of available witnesses duly signed by them and I brought the said truck to Hura P.S. As such there is every reason to believe that the driver and owner of the vehicle namely Firoj Ansary s/o late Kurban Ansary of Kajuli PS Hura Dist Purulia with ill motive were transporting the stone illegally without any valid document in support of carrying stone. So they committed offence punishable U/S- 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver namely Giasuddin Ansary (35) s/o Mohiuddin Ansary of Vill- Hijuli, PS- Hura, Dist- Purulia and owner of vehicle bearing No- JH09Q/3423 namely Firoj Ansary s/o late Kurban Ansary of Kajuli PS Hura Dist Purulia may kindly be started and arrange for its investigation.
