Sir,

In producing here with arrested accused namely Haripada Mahato (28) s/o Lt. Yudhistir Mahato of Vill- Arjunjora, PS Hura, Dist. Purulia along with seized Country Spirit bottles DIL KHUSH (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 28.01.18 at 16.55 hrs received a credible source information I, ASI Kanchan Baran Garain along with force held raid (17.45 hrs.- 18.15hrs) in a house of above noted accused person at Arjunjora Morh under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his house at Arjunjora Morh under Hura PS, Dist Purulia, On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. Then, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. This is to note here that on seeing police party all public/customers fled away. Total 40 (Forty) bottles country sprit (DIL KHUSH) have been seized measuring 600 ML each bottle and value Rs. 35 each.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S-46A(C) B.E Act may kindly be started against the arrested accused person namely Haripada Mahato (28) s/o Lt. Yudhistir Mahato of Vill- Arjunjora, PS Hura, Dist. Purulia and arrange for its investigation.
