Person namely Sanjoy Karmakar(45) S/o-Lt Nirod Baran Karmakar of Vill-Near Mosina School More, PS-Jhalda, Dist-Purulia under arrest with seized articles i.e One black Colour plastic hand bag containing 42 (Forty Two) sealed bottles of Phencyrex-R Cough Syrup (Chlorpheniramine Maleate and Codeine Phosphate Syrup) of M & B MAY & BAKER PHARMACEUTICALS Ltd. Company, Batch No- 06026-SMB1, Exp Date-January of 2018, 100 ml in each bottle Cough Syrup (illegal drugs) and one golden colour Mobile Phone, Model No-Motorola C+ having SIM No-7001344369 which were found from his exclusive possession. I do hereby lodged this written complaint to the effect that on 22.01.18 at 18:05 Hrs, I received a telephonic source information that one person mentioned above and with connivance of others unknown are selling illegal drugs near at Gokul Nagore More. I informed the matter to 1/C Jhalda PS and as per his direction I, ASI Pankaj Kr. Gupta along with ASI Manas Kr Panda, ASI Sk Habibul Hassan and Const -1166 Nabin Ch Majhi left PS at 18:15 Hrs for Gokul Nagore Village More to work out the information with Govt Vehicle No-WB- 56C/8741Vide C.C No-182/18 Dtd-22.01.18 & Vide GDE No-730 Dtd-22.01.18. As soon as we reached near at Gokul Nagore More at about 18:45 Hours, we suddenly saw six (06) persons started running having seen the Police vehicle and we, keeping in mind the source information also started running after them and after a little chase, one person got apprehended and rest five (05) were at large. On interrogation he disclosed his identity as mentioned above and he also disclosed that the others those who were pissed off namely 1. Rajen Banerjee @ KP S/O- Not known of Station Para Purulia PS- Purulia (T) Dist-Purulia 5. Chandan Kuiry S/O Not Known of Jhalda Namo Para, PS -Jhalda, Dist- Purulia. He also disclosed that they are the entire Cough Syrup business partner and since long they have been continuing this business and today they gathered for the purpose of selling drugs to the local youth customers. On being searched found one black Colour plastic hand bag containing 42 (Forty Two) sealed bottles of Phencyrex-R Cough Syrup (Chlorpheniramine Maleate and Codeine Phosphate Syrup) of M & B, MAY & BAKER PHARMACEUTICALS Ltd. Company, Batch No- 06026-SMB1, Exp Date-January of 2018, 100 ml in each bottle Cough Syrup (illegal drugs) which was kept in his right hand and one golden colour Mobile Phone, Model No-Motorola C+ having SIM No-7001344369 which was found in his right pant pocket. On demand he failed to produce any valid documents/ license in respect of keeping the said drugs. So I seized the same from his exclusive possession under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as signed by the apprehended person and also prepared label with seal of one bottle of Phencyrex-T Cough Syrup as sample taking among seized bottles. I arrested Accd. Sanjoy Karmakar (45) S/o- Lt Nirod Baran Karmakar of Vill-Near Mosina School More, PS-Jhalda, Dist-Purulia for violating the Sec-27 of Drugs & Cosmetics Act-1940 and after maintaining all formalities I informed him the ground of arrest.
