Sir,

In producing here with one arrested accused person namely Sk Abbas (22 Yrs) S/o- Sk Jalil Hazi Saheb of Vill- Kantadih, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles, 22(Twenty Two) sealed bottles of ELTUREX-T syrup(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLORIDE) 100 ml in each bottle, manufactured by Elder Pharmaceuticals LTD, batch No- SD17020 Mfg date-May-2017 Expiry date April-2019 in one plastic bag from the possession of the accused person mentioned above. I do here by lodged a written complaint to the effect that on 05.01.18 at 20:05 hrs, in-course of my mobile duty near at Gokulnagar village, I received a telephonic information from my source that Sk Abbas of Kantadih , PS-Jhalda, Dist-Purulia suspiciously standing with huge numbers of cough syrup for selling to others near at Jhalda town Hattola. After having received this information I immediately informed to I/C Jhalda PS and as per direction of I/C Jhalda, I SI Gagan Baisnab along with Constable-1492, Dilip Gorain and Constable- 1021, Lakhikanta Bauri, all of Jhalda PS left Gokulnagar village immediately at 20:10 Hrs to work out the information. We all and reached with Govt. Vehicle at Ananda Bazar near Hattola at 20:25 Hrs. and suddenly seeing the police party one accused person started to flee away and due to hot and little chase, the above noted accused person has been nabbed. On interrogation he disclosed his name and address as mentioned above. He also disclosed that he was running Cough Syrup business since long and today he stood at the spot for the purpose of selling drugs to the local boys customers. On being searched one black colour plastic hand bag containing 22 (Twenty Two) sealed bottles of ELTUREX-T Syrup(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLORIDE) 100 ml in each bottle Cough Syrup (illegal drugs) found in his possession which was grabbed on his right hand. On demand he failed to produce any valid documents/ license in respect of keeping the said drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as the apprehended person and also prepared label with seal of one bottle of Cough Syrup as sample taking among seized bottles. I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 having informed him the ground of arrest.

I, therefore pray before you to start a case against accused person named Sk Abbas (22 Yrs) S/o- Sk Jalil Hazi Saheb of Vill- Kantadih, PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
