Re: Complaint against cheating public by selling fake biris

This is a complaint lodged on behalf of Jeet Biri Manufacturing Co Private Limited having registered office at Dhuliyan Main Road, Dhuliyan, Pin - 742202, District: Murshidabad, West Bengal, representated by its constituted attorney Charu Sk, son of Mahammad Sk, aged about 43 years, residing at Burning Ghat Road, Lalpur, Dhuliyan, Murshidabad, West Bengal – 742202.

That the complainant is carrying on business of manufacturing and marketing of biris under the brand name JEET BIRI in customer packs as well as large retailer packs of which the complainant is the proprietor since at least the year 1998 through its predecessor-in-interest and since 2008 by itself after acquiring rights in the brand names JEET and JEET BIRI. The art works of the said packs are registered under the Copyright Act, 1957 which are also assigned in favour of the complainant. The complainant submits customer packs as well as retailer packs of biris sold by them under the brand name JEET BIRI. In this complaint the term complainant would include the predecessor-in-interest of the present complainant who has assigned its rights in favour of the complainant. The complainant will submit the assignment deeds, if necessary and/or make the same available for examination.

The complainant is a law abiding organization and the brand name JEET and the brand has acquired immense reputation in respect of biris by way of huge sales since 1999. The complainant is duly registered with the central excise authorities from its very inception since the year 2008 and its predecessor in interest was also duly registered with the Central Excise authorities since at least the year 1998. The retailer packs as well as the customer packs were duly approved by the Central Excise Authorities at the launch of the brand as well as from time to time when new variants of the packs have been launched in the market.

The complainant contributes a substantial amount of revenue to the Government in the form of Excise Duty and Goods and Services tax. Inasmuch as, the complainant provides substantial employment to the unorganized sector. Large amount of transporters and dealers are also benefited respectively by transporting and selling the products of the complainant. The complainant will submit documents pertaining to Central Excise, GST, EPF, Income tax when called for. The complainant undertakes that all the figures in the paragraph are true and correct.

The complainant through their market sources have recently come to know that somewhere at Jhalda in Purulia District, under Jhalda Police Station, officials and employees of one Jeet Biri Works LLP is engaged in manufacturing, selling and stocking fake biris in packets and pouches under the brand name JEET BIRI identical to the complainant's brand name and packs. The features of the accused person's customer packs including the brand name are identical to that of the complainant.

The biri packs sold by the accused persons are counterfeit of the complainant's product. The complainant submits customer packs as well as retailer's packs sold by the accused person under the trade mark JEET BIRI.

The inhitation of the brand name has been done by the accused persons solely with the intention of cheating and deceiving the common people by selling biris of the accused persons as the biris manufactured by the complainant herein. The customers as well as the retailers being persons of imperfect recollection are bound to be confused into buying the fake biris of the accused as those of the complainant. The complainant's sales are at the risk of getting affected which would have devastating results in the context of the business as the stock of the complainant is kept hypothecated with Bank due

to loans and the illegal acts of the accused persons are bound to negatively influence the business of the complainant as well as their solvency.

Under the above circumstances you are requested to kindly take suitable legal steps in this regard against the culprit and investigate the matter as per law.
