In producing here with one arrested accused person namely Sanat Dutta(52 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Ihalda, Dist-Purulia and brought under seizure of the following articles, 51 (Fifty One) sealed bottles of WISCOF Cough Syrup (CODEINE PHOSPHATE & TRIPROLIDINE HYDROCHLORIDE) 100 ml in each bottle, manufactured & marketed in India by Windlas Biotech Private LTD, batch No-WWI17011 Mfg date-Oct-2017 Expiry date Sept-2019 in one plastic bag from the possession of the accused person mentioned above. I ASI Sk Habibul Hassan of Ihalda PS do here by lodged a written complaint to the effect that on 21.01.18 at 19:05 hrs, in-course of my mobile duty near at Bandhaghat side, I received an information over Mobile phone from my source that the above arrested accused person, the owner of the Annapurna Medical Hall is coming from Tulin side with huge quantity of Cough Syrup mentioned above for selling clandestinely from his shop styled as "Annapurna Medical Hall" to the youth customers of Jhalda town area. After having received this information I immediately informed to I/C Jhalda PS and as per direction of I/C Jhalda, I ASI Sk Habibul Hassan along with Constable-1166-Nabin Ch. Majhi, Constable-765-Lalmohan Murmu, Constable-1471-Shankar Ruhidas all of Ihalda PS left Bandhaghat More immediately at 19:10 Hrs to work out the information. We, all reached with Govt. Vehicle near Annapurna Medical Hall near at Bus-Stand at 19:15 Hrs. and lurked for Ten (10) minutes (Approx) beside the Medical Hall. Suddenly seeing the Police party, the above mentioned accused person when he reached near his shop, started to flee away with a bag and we immediately surrounded and apprehended him within 10 meters from his shop. On interrogation he disclosed his identity as the owner of the shop as mentioned above. He also disclosed that he was running Cough Syrup business since long from his "Annapurna Medical Hall" illegally and today he was with huge quantity of Cough syrup in a bag bought from Ranchi side, for the purpose of selling illegal drugs to the local youth customers. On being searched one yellow coloured with white stripe Nylon bag having a petti (a brown coloured box) containing 51 (Fifty one) sealed bottles of WISCOF Cough Syrup (CODEINE PHOSPHATE & TRIPROLIDINE HYDROCHLORIDE) 100 ml in each bottle, manufactured & marketed in India by Windlas Biotech Private LTD. batch No-WWI17011 Mfg date-Oct-2017 Expiry date Sept-2019, Cough Syrup (illegal drugs) found in his possession which was grabbed on his right hand. On demand he failed to produce any valid documents/ license in respect of keeping huge quantity of illegal Drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and on request no come forward to be the witness in this case and as well as signed by the apprehended person and also prepared label with seal of one bottle of Cough Syrup as sample taking among the seized bottles. I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 having informed him the ground of arrest and maintaining all formalities.

I, therefore pray before you to start a case against accused person named Sanat Dutta(52 Years) S/O-Lt. Radha Kishore Dutta of Poddar Para, Ward No-9, PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
