I would like to inform you that on 1st May 2007 I got married with said Raj Narayan Singha @ Raj Narayan Singha, S/O - Satya Narayan Singha @ Satya Narayan Singha of vill - Parbatipur, ward no - 13, P.O - Tamruk, P.S - Tamruk, Dist - Purba Medinipur, Pin - 721636 according to Hindu rites and rituals. Thereafter we had been residing as husband and wife at my above said matrimonial house. Since marriage my husband along with his family members [My Father in law Satya Narayan Singha @ Satya Narayan Singha, S/O - At. Amar Nath Singha, Mother in law Utpala Singha @ Utpala Singha and Sister in law Swati Singha @ Swati Singha, W/O - Prasenjit Manna], continuously started ruthless mental and physical torture upon me. At first I tried to adjust with them with my level best, I tolerated all their harassment only to secure our marriage bonding. After birth of a female child out of the said wedlock I thought the situation may develop, but my husband and in laws started tremendous negligence to me and my female child. I tried to protest against their mal activities, they compelled me to leave my matrimonial home while I found that my husband tried to sexually abuse my daughter. Being aggrieved & victimized with the mal activities of my husband & in laws I on & from





January 2016, had to stay at my paternal house apart from my husband to save my daughter. From last two years he and his family members also stopped making any contact with me and my daughter and also refused to maintain us. My husband very recent on 29th October 2017 posted several indecent comments with my photos and my daughter's photos in social networking site from his Facebook account in the name of Raj Narayan Sinha which is operating by my husband, making false remarks about my profession, colleagues and my seniors. It is found that in Facebook a fake account has been created in the name of Krishna Das by giving my photos which is also operating by my husband. It is very much insulting to me when I found that my image tried to being malign in society by my husband. Again the same post which was posted on 29th October 2017 was reposted on 07/01/2018 in a social group of Facebook named 'Kashipur.com'.

Sir, it is my heart & soul request to you to kindly take a look upon this matter and take immediate action against my husband to make him stop from doing such illegal activities and help me out to get rid of menace.
