Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Ananda Bauri, S/O-Manbodh Bauri Vill-Manjhupra PO- Siyada Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 18.01.2018 I received a secret complain over telephone that Sri Ananda Bauri, S/O-Manbodh Bauri Vill-Manjhupra PO- Siyada Dist-PURULIA consuming electricity by means of hooking from nearest It line WBSEDCL.

On the basis of said complaint at about 1.15 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Sanjoy Gorain, OE Kashipur CCC.

Entered the premises of Sri Ananda Bauri, S/O-Manbodh Bauri Vill-Manjhupra PO- Siyada Dist-PURULIA and found that Sri Ananda Bauri consuming electricity dishonestly by means of hooking from nearest It pole of WBSEDCL. Then we disconnect his hooking line, seized the PVC wire (length approx-12 mt.) with hooking device, 1 no bulb with holder, <sup>Load 0.1kw.</sup> After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.45 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
