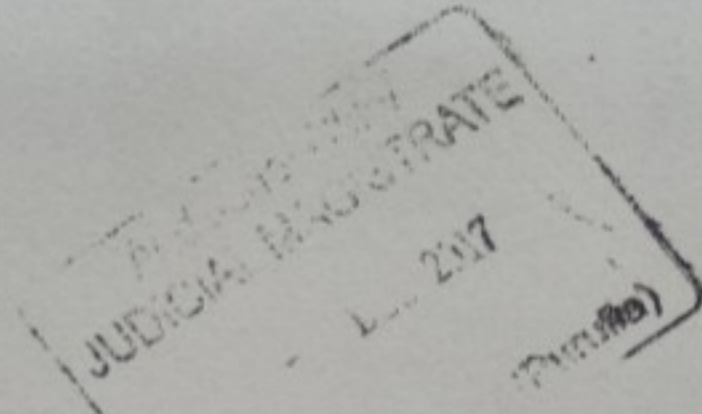
The humble petition of the complainant

Most respectfully beg to State as follows

- 1) That the marriage between the complainant and accused number 1 was solemnized according to Hindu law and Santal rites, customs and usages prevalent in their community in the month of Jaistha about 5/6 years back and since after marriage the complainant went to the matrimonial home of village Khrikagora P.S Kashipur for leading conjugal life with Accused No 1 as husband and wife in a joint family including parents of accused No 1 and others and the said marriage tie is still subsisting
- 2) That at the time of marriage their parents, relatives were present and performed all the wedding functions
- 3) That out of the wedlock of the complainant and accused No 1 they were blessed with a mail child who took birth on 12.04.2014 at Hura Hospital

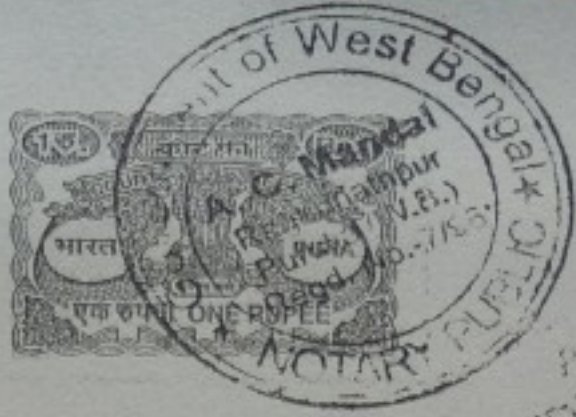

- 4) That after few days the birth of mail child accused No 1 demanded Rs 5000/- (five thousand) From the complainant and directed her to bring the money from her father and any how complainant's father fulfill the demand of accused No 1 and after few days again accused no 1, 2 and 3 demanded further five thousand from her father, any how father of the complainant gave rupees three thousand and again after few days all the accused persons numbering 1, 2 and 3 demanded rupees 20,000 (twenty) thousand through complainant from her father. The complainant's father could not fulfill the said illegal demands of the accused persons as a result accused No 1, 2 and 3 became very much furious and angry and turned vindictive. They started various tortures, ill-treatments, assault on her at their whims. They also keeping her by stopping proper foodings, clothing's the accused No 1, 2 and 3 subjected her to torture and cruelty which is beyond description.
- 5) That complainant after gating information from her parent's house that her father was seriously ill as such she went to her father's house of village Bholardanga.
- 6) That in the absence of the complainant accused No 1 bring a woman namely Behula Hembram on 30.06.2017 and living with her as husband and wife after gating this news complainant came to her matrimonial home after 3/4 days as she and her son was also ill and complainant told her husband (accused No 1) to drove that woman namely Behula Hembram. The accused No 1, 2, 3 and 4 also abusing her in filthy languages and assaulted her mercilessly in different parts of her body causing sever pain of her body and accused No 1 openly declared that he would marry to Behula Hembram in future.
- 7) That on 10.08.2017 at night accused No 1, 2 after taking liquor and accused No 2 and 3 abetting the accused No 1 and 4 to murder the complainant then accused No 1 and 4 dragging the complainant in a room and assaulted mercilessly and fail down her in the floor and gagged the mouth of the complainant with the help of dori (দোরি) attempted with a intention to kill her by something. Complainant any how rescued her from their clutches.
- 8) That the complainant informed the matter to the Kashipur P.S but Police did not take any action as a result complainant send the application to the Superintendent of Police Purulia but till today no action yet has been taken.
- 9) That from the above circumstances it is clear that all the accused persons have jointly committed offence punishable U/S 498A / 323 / 341 / 307 / 34 I.P.C and so they should be punished as per law. The complainant is unable to bear cost of complaint case and hence.

It is therefore prayed that the O/C Kashipur P.S may kindly be directed to investigate the case U/S 156(3) Cr.P.C, treating this complaint petition as F.I.R
