I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that S/O- LT Trilochan Mahato of Village- Achlimka @ Alchima, P.O- chandrapur, P.S.- Kenda, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 03-01-18 at about 04.15P.M, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,
