I do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Kamalesh Bouri S/O Khelan Bouri of Vill -Gobradih, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 16.01.2018 I, Jiaur Rahaman Mondal, AE(S&LP) of Purulia Region, along with Prashant Kishor, AE & Station Manager of Telkalpara CCC & Dayamay Mahato, TSH of Purulia Region, and WBSEDCL conducted a raid programme. at village Gobradih under Purulia(M) P.S. When our team at about 04.00P.M. entered to the Domestic premises of Kamalesh Bouri, we found that he was enjoying electricity dishonestly by means of Direct Hooking from nearest LTOH line and run Domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 04.30 P.M. after completion of inspection & necessary formalities.

Kamalesh Bouri S/O Khelan Bouri of Vill -Gobradih, PS -Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity(Amendment) Act-2007.
