Sir,

I, Pranab Das, son of Late Amulya Das, Resident of Ketika, Professors' Colony, J.K.College Road, crave leave to bring to your kind notice the following contents for treating the same as F.I.R. and to undertake proper legal action against the wrong-doers.

I have given my daughter - Tripti Das in marriage with Sagar Krishna Das, son of Sri Sufal Chandra Das of Locoshed para, Purulia Town on 26-04-16 and since then my daughter has been residing in her matrimonial home. My daughter had conceived and due to some reasons suffered miscarriage on 30/12/17 and at that time she was admitted in Sadar Hospital, Purulia and on being discharged on - 31/12/17 she was escorted to my house by her husband for having proper recovery both mentally and physically. Be it mentioned that my son-in-law is a Railway employee, serving under Chakradharpur Division and he along with his wife, parents and his four sisters, who are already married staying in their respective marital home and Smt. Aditi Das (Ghosh), wife of Rathin Ghosh is a Staff Nurse attached to Sadar Hospital, Purulia, having her marital home at Ketika.

My son-in-law was forcing his wife to go to their house but her mother asked my son-in-law to allow our daughter to remain with us for sometimes more but my son-in-law was dissatisfied on that account.

On 23/01/2018, Sagar Krishna Das reached my house at about 6.00 p.m. and his sister, Aditi Das (Ghosh) arrived in her Scooty. Both of them entered in my house and my son-in-law ordered his wife to accompany him as she showed reluctance, Sagar Krishna dragged her away and at the same time abused me and my wife in filthy language and forced Tripti Das to sit on his Motor-cycle and took her away.

I and my wife out of anxiety for our daughter went to her marital home in my Scooty and no sooner we entered through main gate. My son-in-law, Sagar Krishna Das, his father, Sufal Chandra Das, Smt. Aditi Das (Ghosh), conjointly pounced on me showering abusive threats and started assaulting me mercilessly. While my Behal ordered my son-in-law to kill me and immediately he picked up a cycle pumping instrument and aimed a blow on my head and as I raised my hand the blow landed on my Nose...resulting profuse bleeding and I fell on the ground with pain. As my wife tried to intervene to save my life she was kicked by the female accused person and as a result she also suffered bodily pain.

I sustained injuries on my head and on the face and somehow I could escape from the murderous assault and escaped along with my wife and on way to Sadar Hospital visited your P.S. when I was instructed to rush to hospital and I was admitted as an Indoor patient and I was discharged on the following day.

My daughter was a helpless on looker into the murderous assault that took place on me and my wife.

I would accordingly request you to register a specific case against the accused person under Sections 325, 326, 307, 506 read with Section 34 I.P.Code..and do the needful.
