Sir,

In producing herewith one accused person namely Mihir Bauri (48) S/o Lt Sadhu Bauri of Vill.- Puratan Bero, PS - Raghunathpur, Dist - Purulia under arrest and the following seized articles under seizure list enclosed herewith:-

- 1) 16 (Sixteen) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 180/- (One hundred eighty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 13.01.18 at about 17:45 hrs during my mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his house courtyard at Puratan Bero village. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with C/201 Rabindranath Nag and C/894 Dhananjoy Mondal rushed to the spot to work out the information. On arriving to the house of accused at Puratan Bero village at 18.25 hrs., I apprehended the above noted person after a strong attempt and 03 (three) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Mihir Bauri (48) S/o Lt Sadhu Bauri of Vill.- Puratan Bero, PS - Raghunathpur, Dist - Purulia after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
