In producing herewith 02 (two) accused persons namely (1) Bijoy Gorai (38) S/o Nanda Gorai of Vill.- Chelliyama, PS – Raghunathpur, Dist – Purulia and (2) Haladhar Gorai (22) S/o Shyamapada Gorai of Do under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 25 (Twenty Five) sealed bottles (CS) containing 600 ml each and labeled with DILSE.
- 2) Cash Rs. 380/- (Three hundred eighty rupees) as sale proceed.
- 3) One plastic bag.

I do hereby lodge this complaint regarding that today 13.01.18 at about 18:25 hrs during my mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of their Line Hotel beside Raghunathpur - Chelliyama pitch road at Banda Hospital More. On receiving the reliable source information I communicated with O/C Raghunathpur PS over telephone and as per his instruction I along with JC/666 Lakshi Kanta Lohar and JC/1083 Uttam Mahato rushed to the spot to work out the information. On arriving to the Line Hotel of accused at Banda Hospital more at 19.05 hrs., I apprehended the above noted persons after a strong attempt and 04 (four) customers seeing the Police party managed to escape. On close interrogation that apprehended persons had disclosed their name & address as above mentioned. I asked them to produce any valid paper in support of selling that illicit liquor but they failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused persons namely (1) Bijoy Gorai (38) S/o Nanda Gorai of Vill.- Chelliyama, PS - Raghunathpur, Dist - Purulia and (2) Haladhar Gorai (22) S/o Shyamapada Gorai of Do after preparing proper memo of arrest.

Under the above facts & circumstances, I pray before your honour that a specific case may kindly be started against the said accused persons under proper section of law and arrange for investigation.
