In producing herewith one accused person namely Gour Das (26) S/o Nemai Da of Vill.- Gobranda, PS – Raghunathpur, Dist - Purulia under arrest and the following seized articles under seizure list enclosed herewith: -

- 1) 20 (Twenty) sealed bottles (CS) containing 600 ml each and labeled with DILSE.

I do hereby lodge this complaint regarding that today 13.01.18 at about 19:15 hr during my mobile duty received source information over telephone that the above noted accused person has been selling liquor illegally & clandestinely of his shoe shop a Gobranda More. On receiving the reliable source information I communicated with O/G Raghunathpur PS over telephone and as per his instruction I along with C/23 Chand Mukherjee and C/111 Samulal Tudu rushed to the spot to work out the information. Or arriving to the shoe shop of accused at Gobranda more at 19.45 hrs., I apprehended the above noted person after a strong attempt and 05 (five) customers seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as above mentioned. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper/document in support for selling such liquor. Accordingly I seized all those noted in the above after preparing proper seizure and labeled the seized articles duly signed by the accompanying party in the seizure list and the label.
