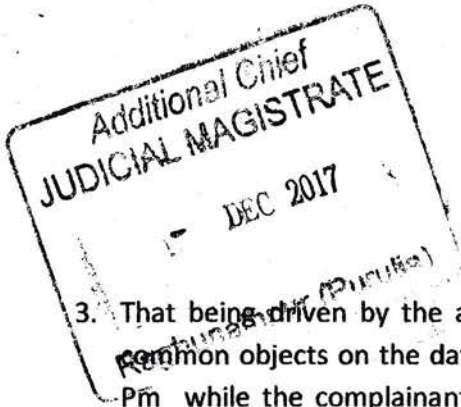
The complainant most respectfully beg to state:-

3. That being driven by the above stated ill motives the accused persons with their common objects on the date and time of the occurrence on 16/11/2017 at about 5 Pm while the complainant was returning back to his residence at village Lalurdih from Raghunathpur market at that time the accused persons wrongfully restrained the complainant on Kuli Rasta In front of their house the accused persons started assaulting the complainant by fist and blows and Lathi indiscriminately as a result the complainant sustained swelling Injury and the fall down on earth

4. That at the relevant time the witnesses no. 2 and 3 also coming through lalurdih Kuli Rasta and with their and other villagers Intervention the accused persons left the complainant and at the time of leaving the P,O the accused persons took away the money amounting to Rs. 1500/- which was kept in the pocket of the shirt of the complainant thus the accused persons committed U/S 341, 323, 379, 34 I.P.C.

5. That on the very following day of the incident the complainant attended Raghunathpur Ps. With a written complainant but the police referred the complainant, advising him to take shelter of court.

6. That having no alternative the complainant lodge complaint before S.P Purulia through registered Post with A/D in spite of that no action has been taken by the police as yet, hence the complainant has compelled to come before you .

In view of the facts and circumstances it is prayed that your honour would be pleased to admit and sent this complaint petition to the O/C Raghunathpur Ps. For Investigation treating this as F.I R U/S 156(3) Cr. P.C
