and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(D)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 03 nos.
- 2) Color TV - 02 nos.
- 3) Freeze - 01 no.
- 4) Electric Bulb - 02 nos.
- 5) CFL - 03 nos.
- 6) Electric pump - 01 no.

Out of which I seized the following.

- 1) PVC 2 Core service connection cable with bypass arrangement - 12 ft' (approx).
- 2) Bulb with Holder - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1:35 PM on 17/01/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
